#### **CHOOSING YOUR BODY PROTECTOR FOR HORSE RIDING**

Three performance levels of body protectors are defined In the standard. The highest Level 3 Is tested at the highest energy Impacts these products should the best protection and prevent more Injuries than lower levels

Level 2 Is the minimum recommended for normal riding. **Level 1** Is recommended for professional jockeys. For additional protection other Items of PPE should be considered, the use of shoulder protectors Is highly recommended along with a riding hat to an appropriate standard.

The whole circumference of the torso

- The bottom edge should be not less than 28mm below the rib cage anteriorly. and should reach a level not more than 30mm above the iliac crests of the pelvis at the sides of the body.
- The arm inlet should be approximately circular and of minimum dimensions. The top of the back of the protector should just reach the level of the seventh
- cervical vertebra (the prominent bone at the base of the neck).
- The front of the protector should reach the top of the sternum.

## Adjustment:

Your body protector has fastening side laces adjustment of waist and chest girth, all times the vest should be adjusted in such a way that the red tape should not be visible to maintain the required protection. The shoulder strip must be closed up to black fastening tape.

#### Protection provides by Garments:

Body protectors give some protection from impacts consequent or falling from horse. Impacts may be against soft or hard ground, or objects such as trees, vehicles, posts or rails. Fallen riders may also be kicked or trodden on.

#### Warnings:


- •Wear ordinary / lightweight cloths under this body protector
- Panel of the horse riding vest are not interchangeable.
  Injuries should be reduced in severity but cannot be entirely prevented. Body
- Protectors do not offer spinal protection or prevent injuries involving severe torsion, flexion, extension or crushing of the body.
- Your D-007053 body protector is suitable for equestrian use only.
  Your body protector must always be done up and adjusted to be dose fit on
- The foam in this Body Protector is sensitive to extremes of temperature. It may become brittle in low temperatures. Its protective value may be reduced if it is subjected to high temperatures.
- •Any alteration, incorrect cleaning or misuse may be detrimental to the performance of your body protector.

## Maintenance & Obsolescence:

Frequent visual Inspection should be made for obvious wear, especially after any accident. A sever fall can result In some cell damage of the foam, obvious signs would be reduced thickness of foam (Dents) or a change in the feel of the foam. If there is any doubt the garment should be replaced. Under normal conditions it is recommended that your body protector is replaced at least every one years.

#### Sizes and fittings:

Take measurements A.B & C as shown and select the corresponding size of Body Protector to try, if you are at the top or the bottom of a size we recommend that you try the two closest sizes.

To benefit from the protection offered by your body protector, you should ensure the fitting of the garment meets the following criteria:

- That it is a close fit worn over light weight clothing
- That no discomfort is caused when you are in a riding position and you are able to maintain a full range of movements.
- That the impact protection is sited over the areas that it is designed to protect, when correctly worn a body protector should cover the following area of the body:
